



Make a Stock Gift

Gifts of appreciated stock can benefit the John F. Kennedy Library Foundation while providing substantial tax benefits for the donor. If you contribute appreciated stock, you pay no capital gains tax upon the transfer of the stock and receive an income tax charitable deduction for the full fair market value of the stock on the date of the gift. There are two ways to make stock gifts:

- **By wire transfer:**

- **By mail:**

Thank you for sending your unendorsed stock certificates by registered mail to Doris Drummond, Chief Financial Officer, John F. Kennedy Library Foundation, Columbia Point, Boston, MA 02125. In a separate envelope, to the same person and address, mail your signed stock powers with a cover letter stating that you wish to donate the securities to the John F. Kennedy Library Foundation.

In either case, be sure to notify the Foundation that you are making a stock transfer so that your gift can be properly acknowledged and credited.
