

**Series 1.3. Private Laws, 87th Congress, April 24, 1961 - Oct. 23, 1962.**

Arrangement: by assigned private law numbers.

This series of Bureau of the Budget Bill Reports contain files for the 87th Congress of the Kennedy Administration. Contained in these files are memoranda to the President indicating approval or disapproval, agency and departmental comments and recommendations, press releases, House and Senate versions of bills, and acts. The files are arranged by assigned private law numbers which refer to a) original bill and b) location in the files. The Congressional Record Index, V. 107, pt. 17 (January 3 - September 27, 1961); V. 108, pt. 18 (January 10 - October 13, 1962); V. 109, pt. 20 (January 9 - December 30, 1963) is the source of bill numbers, subject, sponsorship, and law numbers. Knowledge of either of the first three makes accessible the law number and the location in our files.
